

Annual Meeting Minutes - January 29, 2023

Welcome and Opening Prayer - Pastor Cindy Maddox

<u>Motion</u>: Approval of all three 2022 Congregational Meetings - First: Nalani McCutcheon, Second: Dan Neuger. Motion passed.

<u>Presentation and discussion</u> of budget and OCWM overview led by Nalani McCutcheon. Budget discussion included:

- Overview of pledged vs. unpledged giving,
- Federal employee retention dollars related to pandemic,
- Difference in budgeted vs actual related to Lauren's position,
- Facilities expenses different than expected as result of increased utilities,
- Increased program expenses with resumption of in-person programming,
- Charitable contributions up,
- Overall financial situation is secure.

Motion: Approval of 2023 Budget - First: Elizabeth Olson, Second: Sarah Carlson. Motion passed.

<u>Presentation and discussion</u> of OCWM (Our Church's Wider Mission) led by Nalani McCutcheon. Provides funds to support ministers (e.g. those who serve LBGTQ in military, where other ministers will not serve) or funds to support disaster relief. Note that 10% of pledged OCWM from our congregation stays here for causes that we want to contribute to; 90% goes to the conference.

Report of the Senior Minister

Rev. Cindy Maddox

Last year was another powerful, slightly chaotic, wonderful year in the life of First United Church of Christ, Northfield! Here are just a few highlights.

Worship

For both Lent and Advent we purchased theme materials from "A Sanctified Art," supplementing our worship with beautiful art and liturgy. In the fall of 2023 we kicked off a year-long focus on the power of story called "Unfolding Narratives: Finding Ourselves in God's Story." Due to difficulty getting hosts for Zoom, we took a hiatus from the platform for the summer (live-streaming only to YouTube), but when we looked at the numbers it seemed we were missing some folks so we brought it back in the fall with paid help. Ben Reister is currently serving in this capacity. In October Bob Gregory-Bjorklund and I attended a conference in Nashville with the Convergence Music Project. It was an excellent experience and we brought back some new music to enliven our worship experiences. I continue to be thrilled to work with such amazing staff.

Staff

Unfortunately, we had several turnovers in staff this year. We had to let our previous Office Manager and Director of Communications go at the end of 2022, but Grove Muth very capably took on the role in January while they were home from college. We then hired Kate Kvasnak for the role. She began with us in February and has been a delightful addition to the office staff. In April we learned that Pippa Younger, our Finance Manager, was leaving us to pursue full-time employment. In June we hired Derek Melby to serve as our Finance Manager and we have kept him very busy! Theo Wee announced her retirement, and we celebrated her generously before she left. At the suggestion of our Organist Search Committee, the church hired Catherine Rodland as our new Organist and have been thrilled with the way she is fitting in.

Pastoral Care

We have had many folks ill, grieving, or struggling emotionally this year, keeping both Pastor Lauren and I busy with providing care. It is an honor to be invited into people's lives at such difficult times, and is a fulfilling part of my work.

Adult Education / Faith Formation

Pastor Lauren and I rearranged some of our duties for both logistical sense and to better fit our skills and interests. I have taken on Faith Formation for Adults (including Connect groups) while Lauren is now staffing the Nominating Committee.

Justice Groups

The Social Justice Ministries team continues our work as the hub of social justice efforts in the congregation, with each individual team providing many opportunities for learning and engagement this year. (See individual reports for details.) In addition to our established teams, I also have been working with Jenny Hartley and Fred Rogers to learn more about the devastating conflict in Palestine and Israel. We are blessed to have so many passionate folks leading us in these areas

Finance & Facilities

I continue to staff both the Trustees and the Facilities Committee plus the Stewardship Committee. I also worked with the newly-formed Safety & Security Task Force who brought forth a number of recommendations for keeping our building—and more importantly, our people—safe.

Community Partnerships

In 2023 Northfield's Pride in the Park event separated from the library and became a community event rather than a library-sponsored event. I was asked to represent faith communities on the steering community, and we put on another very successful Pride in the Park. I have now become Chair of the newly formed Northfield Pride, which is sponsoring year-round activities in addition to Pride in the Park. I also continue to attend ISAIAH events as I am able, as well as NAIA and our local women's clergy group.

UCC & MN Conference Involvement

I completed Power & Boundary Training and Anti-Bias Training as required by the MN Conference to maintain my ordination standing. I am currently serving on the Committee on Ministry, which meets quarterly, and on a subcommittee which meets monthly.

Discretionary Fund

This year we spent \$402 on hotel stays for unhoused individuals, \$212 on gas and gas cards, \$1700 on legal assistance, and \$2208 for charitable donations (CAC, Habitat for Humanity, and Clean River Partners). We also took \$1000 to put a deposit on our upcoming Carrie Newcomer concert, but that money will be replaced when we receive payment for tickets. Our current balance is \$6569. We made other charitable donations from the Racial Justice budget line that had been rolled over from previous years.

I am looking forward to all that 2024 will bring, with prayers for guidance on each new adventure that calls to us.

So much happens in a year. It feels nearly impossible to sum up all of the ways in which we experienced and shared God's love this year–joining our voices in song, writing a card of encouragement, checking in over coffee hour or WFFF, delivering a meal, receiving deep listening, being nourished by adult education, feeling energized from the way your team or committee came together, affecting change through justice ministries, being cared for in a time of crisis, learning to see something new through the eyes of a young person–the list can go on! In each of these moments, we are building and being the body of Christ. I am honored to get to work alongside you and bear witness to God's presence right here. Instead of an exhaustive list of what 2023 entailed, I am sharing snapshots of the times I've noticed that "we keep meeting" God in each other and our ministries.

January

• Wednesdays for Food, Friends, and Faith (WFFF) continued through May, then started again in Sept. Bill Bruhiler, Sarah Dennett, Linda Larson, Hans Muessig, Bill Poehlmann, lead with creativity and courage. Creation Care Team members head up compost efforts. Special thanks to Joan Lindholm who is now co-leading WFFF and to all volunteers!

February

- Kate Kvasnak started work, bringing warmth and a can-do attitude to the front office.
- 3 Confirmation students chose intergenerational conversations with older members as their Confirmation project, and said they were a highlight of the class.

March

- With Council and Pastor Cindy's blessings, I submitted a sabbatical proposal for the Lilly Endowment Clergy Renewal program, for my scheduled sabbatical in summer 2024.
- Care Team, Pastor Cindy, and I coordinated support through the first half of the year, given a high level of care needs

April

- Children and Youth celebrated Earth Day with a trash clean up service project in town.
- First UCCers commented positively on 6 Confirmation students' projects: re-written Prayers of Jesus, used weekly in Lenten worship. Many said that students provided meaningful ways to reimagine their (adult) faith and prayer lives.

May

- Pastor Cindy and I swapped a couple of responsibilities to meet logistical needs and strengths. Being the lead on justice ministries, Pastor Cindy took on Adult Education, as justice groups often host education programs. I took on Nominating Committee.
- On Confirmation Sunday, we welcomed 6 of 9 students as full members of First UCC!
- Inspired by Earth Day, children made signs and led an Earth March to town. The Creation Care Team wrote them an encouraging note of thanks for their leadership!

June

- We welcomed Derek Melby on board as our new Finance Manager!
- It was the end of an era: we said goodbye to organist Theo Wee, sending her off with joyful worship, gifts, and her dessert of choice: root beer floats.
- 6 First UCC middle and high school youth, plus a First UCC chaperone embarked on a service-learning trip to Nashville for a week with St. John's and St. Peters churches.

July

- Laura Turek and Children's Team planned the faith formation year, and improved rooms for better faith formation class flow. The Youth Room was moved for space and windows. Jami Reister made it welcoming!
- OWL (Our Whole Lives) Facilitators Dena Stulken, Amanda Pettis Eastvold, Kathy Sandberg and I planned middle *and* high school OWL programs. Sam Steinberg and Steve Reuter became wonderful male leaders for these classes. OWL is growing!

September

- Children's Faith Formation Team recruited 6 new adults to volunteer for faith formation. Thank you adult leaders: Shari Wadleigh, Cheryl Rempel, Mary Carlson, Menk family, Tim and Marian McKone, and others!
- Caitlin Reuter of Children's Faith Formation Team, and her spouse Steve, painted and renovated the entire nursery at the urging of children and youth. It's gorgeous!

October

- Nominating Committee was in full swing, meeting and communicating Aug through Dec to confer on updates regarding committee and council positions.
- First UCC was granted \$51,000 in Lilly Endowment funds for the time of my sabbatical. The congregation and I will both engage in opportunities for rest, funded by this grant!

December

- We concluded the Sanctified Art Advent series, "How Does A Weary World Rejoice?" a theme we realized was very needed, especially given the war in Palestine and Israel.
- 7-8th grade OWL concluded a unit on sexual orientation, gender expression and identity, with a guest panel of 7 LGBTQIA+ adults.
- We said farewell to Conference Minister Shari Prestemon who spent her last Sunday in the MN Conference with us, preaching in worship.

Throughout the year, there are internal, wider church, and community ministries that are ongoing. I'd like to highlight and give thanks to those involved, as well:

- TORCH care packages are sent to first-generation college students from Northfield. Linda Burdell is heading up this ministry, and we send 10-12 boxes, twice a year.
- The Evening Gathering is providing a contemplative, nourishing worship experience.
- Linda Gagnon, along with Leona Openshaw and Barb Altstaetter, have worked tirelessly as a worship arts team, to make the sanctuary's paraments, plants, and flowers look fresh and welcoming.
- Coffee Hour was and is still going strong thanks to leadership by many households, in coordination by Annie Kramer and Sue Evans.
- Special Functions Team runs receptions, also keeping the kitchen tidy and linens clean!
- Knitters group lovingly created prayer shawls, delivered by Care Team members.
- Amanda Pettis Eastvold and her spouse, Matt, created a beautiful photo backdrop this year for those attending the Christmas Eve services.

Report of the Moderator

The church council oversaw a vibrant congregation in 2023 led by our pastors and supported by our office, music, and ancillary staff. There were no large crises but many issues that the council had to weigh in on, mostly brought to them by active church groups. Some examples include focus on immigrant welcoming (our Peruvian family), climate care (Creation Justice Team), Native American reparations (Beyond Land Acknowledgement), and most recently Palestinian/Israeli issues. I think our biggest challenge as a council was to support and encourage active members who are passionate about their particular project while at the same time representing the larger congregation. How do we wisely use the time/financial resources that we have in an equitable and efficient manner? How do we provide stability but also not be afraid to be on the leading edge?

Along with the spiritual and ministry aspects of our church the council worked with the facilities committee, trustees, and the safety task force to make the church building safer, more ecologically appropriate, and maintained properly to last into the future. This is no small task when your building is over 150 years old.

Lastly, we said goodbye and thank you to Theo Wee, our >50 year-long organist and welcomed three new employees—Catherine Rodland, our new organist, Kate Kvasnak, our new office manager, and Derek Melby, our finance manager.

I am thankful for all who add their time and talents in making first UCC an authentic, compassionate, and progressive Christian community.

Report of the Director of Music

Through all the tumult and the strife,
I hear that music ringing;
It finds an echo in my soul –
How can I keep from singing?

These words, which come from one of our church's most beloved hymns (see #476 in The New Century Hymnal), are sung to a melody entitled "Endless Song." What better way to encapsulate this year in our church than by acknowledging the music that, even in tumultuous times, never fails to lift our spirits? I hope that in the year to come music continues to find an echo in your soul and in your voice as well.

Theo Wee, our organist since 1969 and our choirmaster for nearly 35 years as well, played her last service (and what a service it was!) with us on June 11, followed by root beer floats on the front lawn and much fond rejoicing for her 54 years of dedicated artistry. Our good fortune in having her with us for so long has been matched by yet more good fortune in the form of Catherine Rodland, who arrived in September as our new organist. A member of the St. Olaf music faculty and a frequent performer of concerts around the nation, Cathy brings deep talent, local connections, and collaborative generosity to her role, and it is a delight to work with her in shaping and enriching the church's musical life. I am grateful to Pam Carlson, Jay Zoller, Shana Hodel, and Jane Turpin Moore, who filled in at the organ and piano over the summer, in between Theo's departure and Cathy's arrival. Thanks as well to my fellow committee members - Marty Hodel, Carrie Melby, Ben Gottfried, Mary Savina, and my colleagues Cindy Maddox and Bob Gregory-Bjorklund; we call ourselves the Organizers - who brought our search for a new organist to a successful conclusion.

In 2023 we continued a program from the previous year: payment for the use in worship of African-American spirituals, whose unknown composers never received compensation for their creations. As a form of musical reparations, our church's payments are meant to ensure direct support for local Black musicians and are thus being sent to Sounds of Blackness, the multiple-Grammy-winning ensemble based in the Twin Cities.

On December 10 the Senior Choir shared its annual chorapalooza. This year's theme was Peace on Earth, featuring several guest musicians from St. Olaf and anthems by Sasha Johnson Manning, Felix Mendelssohn, Errollyn Wallen, G.F. Handel, and John Gardner. Another annual tradition is the welcoming of other musicians and groups into worship. The Spirit Voices were joined by Lori Dokken and Steve Jennings on January 15 and by the Laura Baker Choir on May 21; the Northfield Wind Quintet (including our own Kathy Szydlo) performed on July 30; and the Northfield Handbell Choir performed on May 7 and November 12. It's worth celebrating the

fact that our church's handbells, acquired in 2003, are now 20 years old! (Thanks to Scott Richardson and Margit Carson Johnson for noting that fact along with many others about the musical life of our church in the book they created this year, *Our History Continues: The History of First United Church of Christ Northfield*, 1965-2022.) As it has for many years, First UCC also hosted one of the Northfield Noontime Organ Recitals on August 2 with Stephen May on the bench.

Volunteers are the lifeblood of any church, and that is particularly true in the realm of music. My thanks go to the steadfast members of the Senior Choir and the Spirit Voices, without whom our church would be much less united in song and in spirit. Thanks as well to all the vocal and instrumental soloists from the congregation and the community who have contributed their talents this year: Annika Reister, Andrea Een, Mark and Holly Fischer, David Hougen-Eitzman, Kathy Szydlo, Donna McMillan, Brian Borovsky, Myrtle Lemon-Todd, Kathy Kanazawa, Kay Sahlin, Anne Sawyer, Joey Heinz, Marty Hodel, Janet Muth, Tom Niemisto, Ben Reister, Amelia McNeil-Maddox, Henry Beimers, William Beimers, Cate Carson, Caroline Flaten, and Faiz Wareh. And thanks to everyone in the congregation who joins in on the hymns and the service music. Keep it up!

Last and not least in the least, my thanks go to my talented, thoughtful, and generous colleagues: Theo Wee and Cathy Rodland at the organ, Bob Gregory-Bjorklund with Spirit Voices and much else, Brynn Artley at the audio and video controls every week, and Mark Fischer with his ear for a well-tuned piano. I am so grateful for Cindy Maddox and Lauren Baske Davis: not every director of music is lucky enough to enjoy such a fruitful collaboration with clergy who know about and care about music in worship.

Music is a gift from God to all of us, and the best way to enjoy that gift is to give it right back and to share it with each other. Come share your gifts.

Ministry Reports

Beyond Land Acknowledgement Team

The congregation adopted a First UCC Land Acknowledgement statement in January 2022. The statement is framed and exhibited near the east door. As of September, a lawn sign that states "We Stand on Dakota Land" was added to our front lawn. Additional signs are appearing in front of other churches in town.

Throughout the year articles in the Social Justice Covenant Newsletter have featured resources and opportunities to learn more about and listen carefully to Indigenous voices and perspectives. Numerous books, podcasts, websites, art exhibits, and sites to visit were cited.

Dorothea Hrossowyc, Holly Fischer and Pastor Cindy led a Lenten reflection service of lament in March - a moment to share grief about the Indigenous people who lived here and suffered ethnic cleansing, forced removal, suffering and death.

During the legislative session the team lobbied our elected state representatives about bills related to programs for urban and rural Indigenous Minnesotans.

In May, former First UCC Northfield Minister and retired Conference Minister David McMahill spoke about the mission and contours of Congregationalism during the time of our church's founding in 1855.

Throughout the summer the Beyond Land Acknowledgement team offered semi-monthly "field trips" to the MN History Center, Jeffers Petroglyphs, Red Wing's He Mni Can/Barn Bluff, Historic Fort Snelling, Bdote, Shakopee Hoçokata ti, and the Cannon River crossing at Waterford in the Lower Arb along a probable Dakota trail.

In July Senior Pastor Cindy and the team invited community members supportive of land acknowledgement statements to convene and discuss ways that we can share information, ideas and resources to support Indigenous people.

David Garelick of the Indian Land Trust Foundation spoke in December at a community forum about supporting American Indian nations and people in the recovery and control of their rightful homelands.

Immigrant Welcoming Ministry Team: 2023 Highlights for a Year of Abundance

A second year of advocacy on behalf of the residents of Viking Terrace has resulted in keeping the oppressive owner from evicting and displacing residents. This fall, Lakeshore was hit with a class action complaint for violating Federal law for conspiracy to price fix rents. In November, many members participated in a prayer walk through Viking Terrace organized by United Methodist Pastor Rachel Morey. A petition was circulated that day and to other churches and organizations, garnering over 200 signatures for Lakeshore to sell the park to the residents. An offer to buy the park to turn it into a resident-owned cooperative was sent to the company Lakeshore in early December.

We secured funding from Northfield's Housing and Redevelopment Authority to assist Viking mobile home owners with needed repairs, specifically installing window film and heat tape for winter weatherization and distributed smoke alarms and carbon monoxide detectors.

First UCC members participated in a day of labor with Rice County Habitat for Humanity building homes in Faribault for families from Somalia and Ethiopia.

Our church donated \$1,000 to Habitat for Humanity this year and \$500 to the migrant sanctuary House of Mercy in Nogales, Mexico.

We chose to help a family from Peru seeking asylum. Members have housed the family, provided transportation, food and medical needs, English language sessions and so much more throughout this year. A Special Offering was successful in raising over \$13,000 to support asylum-seeking families

We lobbied and were successful in passage of law allowing for undocumented persons to obtain their driver's licenses and our Peruvian father got his.

Members spent a day learning and working at Regi and Amy Haslett Marroquin's Regenerative Agriculture farms.

We volunteered to help settle Afghan refugees in the Metro area.

After witnessing migrant conditions at the U.S. border, First UCC's members attended a lecture to learn how to become involved in this national tragedy. This information was also presented at St. John's Courageous Conversations and at the district meeting of the United Methodist River Valley Women in Faith.

Children's Spanish language books were distributed to Viking Terrace's Little Library.

This fall members volunteered to refurbish an abandoned house for the Valdez family - The Starfish Project. Starfish has been adopted as a program of Rice County Habitat and plans are underway for a second home to be worked on in 2024.

Creation Justice Team

In 2023, we spent much of our time looking into whether First UCC should covenant to become a Creation Justice church. Becoming a Creation Justice church formalizes and strengthens our mission to seek "justice for all of God's creation." Our team's preparation for a congregation-wide vote has involved research and deep discernment on our part. In consultation with our pastors, we made a recommendation to Council that the church go forward with the formal processes involved. Council has agreed. We have been educating the congregation about creation justice, and members will vote at the 2024 Annual Meeting on whether or not to pursue this. As a result of our discernment, we have changed our team's name from Creation Care to Creation Justice.

Our initial form of education on this was a three-week series in October led by Mary Savina. She directed participants in a discussion of UCC Minister for Environmental Justice, Brooks Berndt's book *Cathedral on Fire*. These discussions followed a Sunday when Pastor Cindy delivered a moving environmental justice-themed sermon. Some thirty people attended one or more of the book discussions.

We have continued our zero-waste efforts and have been delighted this year to see ever-increasing, tangible results. Various people from adults to youth have begun to see the value of composting, growing comfortable with our practicing it at the church, and have increasingly taken the initiative to make it happen. Thanks to a very generous anonymous donation, the church found it possible to start purchasing new receptacles that make recycling and composting clearer and better. We now have compost pick-up service with Curbside Compost Cooperative and fill their 35 gallon institutional bin nearly every week. These organics now become usable

soil without creating the global warming gas, methane, that this material would generate at the landfill.

We ended 2022 answering a request from Mayflower Church for our congregation to formally vote to become one of the five in the Minnesota Conference needed for a version of the 2022 Minnesota Annual Conference "electrification" resolution to be considered at the UCC General Synod. The proposed resolution passed in 2023. Increasingly, electric power is generated from carbon-free sources, so this resolution calls on churches to plan ahead. Congregations are also asked to educate congregants to do this planning and make conversions to electrical power sources at home. We held a WFFF education workshop on this for congregants, used a Covenant article to promote it, and have been working with the Facilities Committee. With our help, the committee has been pursuing the resolution's call while also exploring other innovative means to make the church carbon-free as soon as possible.

Late in the summer, we offered congregants the chance to participate in the national UCC environmental justice Cards of Hope campaign. Nearly 200 congregants (almost everyone in attendance at two services) joined others nation-wide (some ten-thousand people) in petitioning the EPA to strengthen about a dozen regulations coming up for review.

Racial Justice Team

We are currently seeking a new person to lead our Racial Justice Team.

ISAIAH

Our congregation belongs to ISAIAH, a Minnesota faith-based coalition that works for a multi-racial democracy and an economy where everyone can thrive. This year many people in our congregation participated in our work with our chief contact people being Leota Goodney and Matt Rohn. Pastor Lauren and Pastor Cindy have provided support and continue to call us into action "to do justice, act with loving kindness and walk humbly …" Micah 6:8.

Early in the year, ISAIAH at First UCC focused our efforts on the legislative session at the State Capitol. We joined other ISAIAH members in southern Minnesota and met weekly for updates from the ISAIAH-affiliated legislators representing Northfield, Rochester, and St. Peter. They provided updates on the status of bills and issues. A group of 35 from Northfield went to the state capitol in March to meet with legislators and advocate for housing, health care, child care, and paid family leave.

ISAIAH MN, in cooperation with other groups and allied legislators, was instrumental in getting a wide array of legislation passed that will improve people's lives. Legislation passed includes 100% clean energy, paid family and medical leave, money for childcare, a start on improving the health care system, driver's licenses for people without US papers, funding for housing, and much more.

Members of our congregation attended various statewide ISAIAH events including monthly central leadership team meetings to plan the actions of the organization. Several members of the congregation were part of a leadership assembly in June where we celebrated the successes of the legislative session and prepared for the work ahead. We also had a local celebration in Odd Fellows Park and brainstormed what needs to happen next.

Locally ISAIAH Northfield held several house meetings and forums, including a forum in our sanctuary to gather ideas and information about where we need to put our efforts next. We held a listening session with Representative Kristi Prusell in November where we talked about

transportation, health care, gun violence, housing and environmental issues. This was part of a statewide effort which involved over 5,600 individuals.

All of this listening work culminated in a statewide session in December attended by four people from our congregation. We reviewed a revised values agenda laying out our overall goals for a multi-racial democracy where everyone has a voice and an economy that supports everyone. We discussed the specific priorities for the next 18 months and the plan of action.

In December ISAIAH Northfield led a forum with five legislators to learn more about and support the MN health public option.

Members of our congregation are working with the ISAIAH Rural Organizing Project, led by Todd Lippert. This effort is to support people in rural Minnesota in advocating locally and at the state level for clean water, soil health, child care, health care, housing, and other issues that are important to their rural community. This effort includes research visits with County and City leaders and is ongoing.

Standing Committees of the Council

Facilities Committee

This year has been very busy and challenging for the Facilities committee.

Water damage repairs

The year began with repairs to Room 127. This classroom was damaged due to a water leak in 2022. The repairs included replacing drywall, trim, baseboard as well as painting the repaired items and parts of the ceiling.

Ceiling fans

The ceiling fans that were ordered in early 2022 were finally located from the vendor but turned out to not be suitable for our needs. We researched various models and have selected ones that will fit our needs in the Sanctuary. An installation date is still pending.

Steeple and bricks

In March brick fragments were noticed by the steeple entrance door. The cause of these fragments was loose brick on the sloped sections of the Southeast corner of the steeple. After consulting with various vendors and an architect it has been determined that the Southeast corner of the steeple is separating from the rest of the structure and will need to be addressed in the next few years. The cause is water permeating the brick and mortar.

A contractor was brought in to repair the loose brick as well as provide a temporary fix to the column. We have addressed the issue for the time being but within the next few years this corner will need to be rebuilt. We don't have a definite timeline as we have to see what develops with the repairs we have done.

While we are on the topic of bricks it should also be noted that the brick facades on the old portion of the building will need some tuck pointing as well as some brick replacing. There is no timeline for this work as we are developing a long-range plan to maintain the brickwork.

Lawn care

During the Spring we switched providers for our lawn care as well as our snow removal. We were very pleased with Malecha Landscaping for their work on our property. It should be noted that 90% of the work done by Malecha Landscaping utilizes electric/battery operated equipment.

Roof replacement

Our roofs (both sloped and flat) were damaged by a hail storm on April 12, 2022. In May of 2023 we began the first phase of the roofing project, which included removing the solar panels

and replacing the shingles on all the sloped portions of the roof including the steeple tower. This part of the project went well and was completed in May. There was some collateral damage to some screens and our retaining wall which was addressed.

Due to negotiating delays the second phase of the project - replacing the flat roofs - was not able to be completed before the cold weather moved in. The replacement of the flat roofs and the replacement of the gutters will happen during the Spring of 2024. The plan is to have the roofing replacement completed by next Summer.

Solar panels

The solar panels were removed in May to enable replacing the roof shingles. The panels and their inverters were originally installed in late 2014. In 2016 one third of the panels stopped functioning. In early 2017 the company that manufactured the inverters, tenK, went out of business. Initially the conjecture at the time was that the malfunctioning panels were caused by faulty inverters. Since the company that manufactured the inverters was no longer in business it was decided that the cost to investigate the cause of the failures was prohibitive.

When the panels were removed and inspected it was discovered that a squirrel had chewed through some of the inverter wires causing the failure. Since the roof replacement is ongoing and we are still negotiating with insurance, a final decision on the future of the panels will be coming sometime in the Spring. Currently the panels and all the components are safely stored waiting for our final decision.

Safety and Security items

This year we installed a number of safety items around the church including: severe weather signs, "No Exit" signs, first aid kit location sign, door numbers (both outside and inside) and glass panels to Pastor Cindy's and Pastor Lauren's office doors.

A component of improving the safety and security of our building involved considerable research for a new keyless entry system and three security cameras. We secured four estimates and decided to utilize Custom Alarm from Rochester, MN.

Over the years a considerable amount of keys have been given out to the church's outside doors. There were several unsuccessful attempts to recover or account for all of them. Considering the number of people that would potentially have access to the building we decided that a keyless entry system would be our best solution.

A card reader and keypad will be located on the handicap access pedestal by the office doors and another will be located by the Daycare door. Either key fobs or cards will be issued to individuals who need access. The advantage of this system will be that we can easily program when

individual cards will have access and the programming can be easily changed. In addition we have rekeyed the outside doors so old keys will not work. The old keys will still work on the inside doors. As part of this process we have begun looking into our policies regarding building access in addition to looking at our agreements with various groups who use our facilities.

As an additional security precaution we have installed three security cameras. One is located by the office doors looking over the parking lot entry path to those doors. Another is located above Pastor Cindy's office windows overlooking the rest of the parking lot and the third is on the East wall, above Pastor Cindy's windows overlooking the main entrance.

In addition, we will be replacing the Daycare entry door with a commercial door. This door has been in pretty bad shape and needed to be replaced.

The security cameras were installed in December 2023 with the rest of the items scheduled for installation in January, 2024.

In July we had a full fire inspection. It had been many years since the last inspection and as could be expected we had some issues. We have remedied a lot of the faults which included extending the Fire Department Connection (FDC) access pipe on the North side of the building, replacing FDC alarm/strobe, replacing all the exit signs with exit/lighted signs, adding occupancy limit signs, adding new signs for electrical room and sprinkler room, completing a sprinkler inspection, completing a 5 year hydrostatic sprinkler inspection, adding a Knox box to the North door, adding 4 additional smoke detectors, adding a monitoring panel for concealed duct smoke detectors, clearing landscaping by door 3, and removing four fire pulls.

Items still to be completed in January 2024 are rehanging a fire door that would not close, completing a fire monitoring system inspection, mapping of all the smoke detectors in the building, adding door closure mechanisms to storage room doors, and conducting a final fire inspection.

Rooftop air conditioner

While the rooftop air conditioning unit continues to provide some challenges it functioned well during the past summer. This unit provides cooling for the Assembly Room and the Sanctuary. There was one Sunday when it was not functioning but we were able to troubleshoot the problem and remedy it fairly quickly.

Preparations for winter

Our committee had an October work morning this year when we attended to numerous items preparing our building for the colder months. We stored the green plastic chairs in the storage room, removed the screens from the Memorial Garden windows, checked all the various HVAC

filters, cleaned and started the air purifiers, modified the heating schedule in the building (we are reducing the temperature at night) to save energy and moved the bike racks to winter storage.

We also reviewed all our maintenance commitments and evaluated them based on cost and value. We continue to utilize some of the providers while others were not renewed and replaced.

Additional maintenance items

In addition, throughout the year there were numerous maintenance needs such as cleaning and changing filters on the electric furnaces, AC unit, air exchanger, lower level dehumidifier and air purifiers. There were also repairs to the lower level dehumidifier, interior and exterior outlets, modifying kitchen sink cabinet for rodent control, replacing a lawn pop up cover, boiler repair, and adding an expansion tank to the water heater.

Long term planning

Our committee also began planning for the future needs of our building and congregation. We have developed both a short and long term budget for the consideration of the Trustees. Many items have been identified that will need to be addressed over the next ten years. Considering the age of the building and the ongoing needs for capital improvements as well as maintenance we hope our initial planning will begin to outline a path forward.

The committee continues to be prudent in its use of its gracious resources, grateful for the members who volunteer on the committee or help along the way, and humble in serving this special place of worship.
